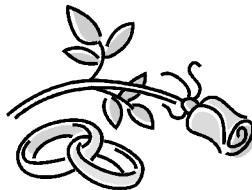

### OUR UNUSED PROPERTY

Over many years we have, from time to time, considered to what use we could put our unused 3+ acres. That property has contributed little to our programs other than a little

Recently we have become aware that California Lutheran Homes (CLH) is interested in developing a senior housing facility in Santa Barbara. We have followed-up on that interest and have met with representatives from California Lutheran Homes and its affiliated property development organization. It would appear that there is a very definite potential to develop our unused property for a senior housing project through CLH. To do so we would

need to either sell or enter into a long term lease with CLH or its development organization for that unused acreage. We have scheduled a presentation by CLH and its affiliated development organization to be held at 9:15am on Sunday, April 27<sup>th</sup>. We invite you to attend. ## Ministries

Spring is here! He is risen! He is risen, indeed! Take this time to make a renewal within your family to be more intentional about faith at home...it's never too late to commit to a fresh start! I'm running a series on faith formation at home, and how what you do the OTHER six days of the week, regardless of how often you attend worship services, is where it all REALLY begins. In that spirit, here are some reminder notes:

Maybe Sunday morning is legitimately a bad time for your family to focus on God; but be prepared to offset that time elsewhere in your schedule. Five or ten minutes every day for six days will have more of a cumulative impact than one hour on Sunday morning.

If you need tips on how to play that out at home, come to church, or even give me a call or an email ([kidzndrumz@aol.com](mailto:kidzndrumz@aol.com)) and we'll talk about ways to get that faith journey moving. Here's why it's important:

"I'll bring my children when they're old enough," many parents promise, not quite clear when that age will be. Any age is an appropriate age to join the church, but for parents there may be no age when bringing children to worship is an easy task. But what it comes down to is a pair of rock solid truths: Children

Need the Church and the Church Needs Children. Here are examples of each:

### **Why do children need the church?**

-Children experience the beauty of music and art as expressions of human creativity and of worship.

### **Why does the church need children?**

-Children serve as reminders of grace. We all receive Christ's presence as a gift, not because we are worthy.

### **Thought for the month:**

Faith formation at home is not boning up on theology; if you're worried that your four year old (or fourteen year old) will see through how much you really do or don't know about church doctrine, the Bible, etc., you're worried about the wrong questions.

Kids naturally hate school because from their limited perspectives, they're tasked with finding a bunch of meaningless answers. However, faith is the exact opposite: it's finding *meaning when there is no clear answer*. Do we brush it aside, explain it away, or be honest enough to admit we don't know and commit to finding some answers together? Only when we are brave enough to take members of our family and ACT on a question do the true relationships begin to form.

### **Call Committee Progress**

The Call Committee has now interviewed 4 pastoral candidates in 2008. We have attended worship services of two of these pastors and heard sermons from a third pastor online. The search has been narrowed to three of these four. On March 17 the Committee extended an invitation to one candidate to return for a second interview. This candidate is in the discernment process since two other congregations have approached him as well. So we are waiting and praying.

The purpose of the second interview is for the candidate to meet with our staff, discuss the specifics of compensation and housing, and for both parties to decide if this is a match. I have formed a housing task force to work with an incoming pastor and provide options for housing. Once both parties are in agreement, the proposed candidate and compensation package would be approved by the church council. Thereafter a congregational meeting would be scheduled and both the pastor call and compensation package voted on.

The Call Committee has worked diligently this year on your behalf. This process has taken longer than any of us would have imagined. However the Lord doesn't usually work on our time table. Sometimes we are asked to wait and watch. We pray for patience, discernment and ask the Holy Spirit to lead us to the candidate who is the best fit for Trinity.

### Get an Advance Directive

#### *What is an advance directive?*

In 1983, California became the first state to create a durable power of attorney specifically for health-care decisions. Today all adults can benefit from thinking about what their healthcare choices would be if they are unable to speak for themselves. These decisions can be written down in an advance directive so that others know exactly what they are. Advance directives come in two main forms:

A "healthcare power of attorney" documents the person you select to be your voice for your healthcare decisions if you cannot speak for yourself.

A "living will" documents what kinds of medical treatment you would or would not want at the end of life.

*April* is the time to get your financial house in order and it is also a perfect time to review or complete your *advance directive*. Being in good health is the best time to make these important decisions. Research has shown that the majority of people believe having an advance directive is a good idea however; most people have not actually completed the process. Many attorneys may include an advance directive as part of the estate planning process to be sure review your current documents. In addition check that

phone number of your physician, your healthcare agent and your alternative agent are up to date. In addition make sure your physician and healthcare agent have a copy. Review your decisions. Are your wishes still the same? Have you reviewed your wishes with your healthcare agent? Per Steven Frank, estate planning attorney in Santa Barbara, if your advance directive was completed before 2000 you probably should update it. In July 2000 the Health Care Decisions Law consolidated California's previous advance directive laws to make it easier for individuals to make their preferences known through written and oral communication.

For all of you who do not have an advance directive and would like one I will have the document "5 Wishes" available on Parish Nurse Sunday April 27<sup>th</sup>. ## FORNICATION

Last month brought us the Spitzer scandal and images of his beleaguered spouse Silda grimly looking on as the New York governor apologized to the citizens of his state for his moral lapses. People were saying, in New Agey fashion, that Spitzer “has to work through his issues.” But my thought was “This man needs Jesus.”

Here was a guy once touted as “Sheriff of Wall Street” for his fierce crusades against financial players who were not playing by the rules. But my gut feeling, given his relentless self-promotion and take-no-prisoners policies, is that Spitzer’s moral dudgeon was disconnected from spirituality. One thinks of another crusader, William Wilberforce, as a counter example. He was anchored in the promises of God. He had a living relationship with Jesus Christ. This kind of centering and grounding seems to have eluded the fallen politico.

From a Christian point of view, what is going on in this case? St. Paul, in his first letter to the Corinthians, calls it *porneia* or fornication in English. “The body,” he writes, “is meant not for *porneia* but for the Lord.” It is inconceivable to him that a person, whose body is a “member” of Christ, should make his body a “member” of a prostitute, i.e. be united with her (note the exclusive preoccupation with males). “Shun fornication!” thunders the apostle.

Now let’s be frank. The Bible is anything but univocal when it comes to matters sexual. One thinks of those randy patriarchs with their multiple wives and countless concubines. Or of Tamar, unreproved for her fling at turning a trick (Genesis 38...consult it when the kids aren’t around). Then there’s the monstrous Lot who, at Sodom, went uncensored for pimping for his daughters.

Given the ambiguous picture the Bible draws about sex, it’s unsurprising that Christians continue to debate the contours of a faithful and consistent biblical sexual ethic. We discuss things of which scripture is ignorant, like transgendered persons and those involved in loving, committed, non-exploitive same-sex relationships. And just now, our Evangelical Lutheran Church in America is circulating a Social Statement on Human Sexuality that, officials emphasize, is a *draft* only.

Surely we must remain open to the future tutelage of the Holy Spirit and sensitive to the dilemmas of people in real life situations. Yet one need not be a fundamentalist or a

focus on the Family to uphold, defend and celebrate certain perspectives on sex and relationships that we believe, as near as we can tell, are divine.

One perspective involves marriage. The church teaches that it is not only an institution conducing to the safety of children and the stability of society which, in evolutionary terms, it clearly is. Marriage is also a calling...not all have it...to a relationship of mutual, self-givng love. It is a ministry, one with one. It is to be ended only by death, which means that every divorce, however necessary, involves tragedy and sin.

The church speaks of God when it speaks of marriage. In the Bible Jesus knew, God is pictured as “marrying” Israel, his “bride.” When Israelites run after idol lovers, they are adulterous. In the New Testament, the church is the Bride of Christ, for whom he died and to whom he is faithful. From the Latin *fides*, faith, faithfulness, fidelity: they’re all involved in marriage which exists in a fallen, sinful world. Those who enjoy the gift and task of marriage are called to be self-emptying Christs, one to another, and to resist the temptations of a louche world.

Like I said, Eliot Spitzer needs Jesus.

## Is There a Draft in Here?

The 2001 national Assembly of the Evangelical Lutheran Church in America mandated that a social statement on human sexuality be developed by the church. Last month a draft statement was released by the Task Force for ELCA Studies on Sexuality chaired by Bishop Peter Strommen of the Northeastern Minnesota Synod and composed of lay and clergy from around the country – a psychologist from Puerto Rico was also included.

Social statements offer a framework for moral discernment for members and congregations, and serve to set policy for the denomination and guide its advocacy. They deal in what I know as “middle axioms” – principles that fall somewhere between very general moral principles (love your neighbor) and detailed policies (we should pass tax bill such-and-such).

On the whole I like this document. It is grounded in sound biblical and confessional theology. It takes the measure both of the complexity of the subject and the seismic changes, social and institutional, over the last fifty years. “These include,” in the draft’s enumeration, “changes in gender roles and expectations, family planning, attitudes toward the body, sexual practices, forms of sexual exploitation, fertility management, forms of courtship, partnering and family life. The draft goes on to note the connections between these changes and broad economic, technological and demographic ones. The draft recognizes that a variety of factors can make it difficult to behave according to God’s will and scriptural norms and values.

Although many passages reflect a cautious tone, I like the way it can be straightforward and unequivocal. “The church does not support non-monogamous, promiscuous and transient sexual relationships or casual sexual encounters. Indulging immediate desires for satisfaction, sexual or otherwise, is to ‘gratify the desires of the flesh.’” Gal. 6:16

Marriage is a covenant of commitment, blessed by God, that allows persons to flourish in a context of trust, intimacy and safety. The draft assumes that marriage is for life and is between a man and a woman.

I am disappointed that, in the matter of same-gender committed relationships, the draft recognizes that the ELCA is not of one mind on the subject, *and lets it go at that*. Perhaps this is all we can expect at the present time. But I wish the church would lead

championing the full inclusion of sexual minorities in civil society and in the life of the church. Would we lose members if the ELCA took a bold stand for the sake of love and justice? Surely. But that is only an observation, not an argument.

The draft's opening spiritual discussion is richly scriptural and thoroughly Lutheran. The incarnation of Christ in our fallen world means that "neither 'bodiliness' (including bodily desire) nor materiality (all of creation) rightly can be equated with sin." Sexuality is part of who we are as creatures of God. Yet sexuality, like any other aspect of our existence, can be an arena for sin and for hurting rather than helping the neighbor. Yet we understand ourselves as justified by grace, and thus freed from self for ministry to the common good. Grace does not liberate us to do whatever we want, but turns us toward the neighbor to do what is best for her or him. As the draft puts it, through the gospel "God called, claimed and sent us to bear God's mercy to our neighbor."

This is the basis of Lutheran sexual ethics.
